USDA Natural Resources Conservation Service Loans*

Direct Farm Operating Loan:

For costs associated with improving profitability (ex: purchasing livestock, equipment, grain, enhancing conservation). Loan max: \$400,000.

How to Apply: Loan application form and instructions here.

Gaurenteed Farm Loan:

Farm Ownership Loans: may be used to purchase farmland, construct or repair buildings, develop farmland to promote soil and water conservation.

Conservation Loans: for implementing conservation practices approved by the USDA's NRCS, such as reducing soil erosion, improving water quality, and promoting sustainable practices. Farm Ownership and Conservation loan max: \$1,776,000.
